Local Councils, Internal Drainage Boards and other Smaller Authorities in England

Annual return for the year ended 31 March 2017

Every smaller authority in England with an annual turnover of £6.5 million or less must complete an annual return at the end of each financial year in accordance with proper practices summarising its activities. In this annual return the term 'smaller authority'* includes a Parish Meeting, a Parish Council, a Town Council and an Internal Drainage Board.

The annual return on pages 2 to 4 is made up of three sections:

- **Sections 1 and 2** are completed by the smaller authority. **Smaller authorities must approve Section 1 before Section 2.**
- **Section 3** is completed by the external auditor.

In addition, the **internal audit report** is completed by the smaller authority's internal audit provider.

Each smaller authority must approve Section 1 and Section 2 in order and in accordance with the requirements of the Accounts and Audit Regulations 2015.

Completing your annual return

Guidance notes, including a completion checklist, are provided on page 6 and at relevant points in the annual return.

Complete all highlighted sections. Do not leave any highlighted box blank. Incomplete or incorrect returns require additional external auditor work and may incur additional costs.

Send the annual return, together with the bank reconciliation as at 31 March 2017, an explanation of any significant year on year variances in the accounting statements, **your notification of the commencement date of the period for the exercise of public rights** and any additional information requested, to your external auditor by the due date.

Your external auditor will ask for any additional documents needed for their work. Unless requested, do not send any original financial records to the external auditor.

Once the external auditor has completed their work, certified annual returns will be returned to the smaller authority for publication and public display of Sections 1, 2 and 3. You must publish and display the annual return, including the external auditor's report, by 30 September 2017.

It should not be necessary for you to contact the external auditor for guidance.

Guidance notes on completing the 2016/17 annual return

1. You must apply proper practices for preparing this annual return. Matters reported

Trust Funds

The Authority is the sole managing trustee of the Miners Welfare Recreation Ground, Thomas Albert Hawkins' Charity and the Cheslyn Hay Recreation Ground. Regulations stipulate that Trustees must file annual updates with the Charity Commission within 10 months of their financial year end.

It has come to our attention that the Authority has not submitted each of the Trust's annual updates to the Charity Commission by the date required. The Miners Welfare Recreation Ground's financial year ended on 5 April 2016, meaning their documents should have been filed by 5 February 2017. The Authority submitted their documents to the Charity Commission on 27 March 2017, 50 days later than required. The Thomas Albert Hawkins' Charity's financial year ended on 6 April 2016, meaning their documents should have been filed by 6 February 2017. The Authority submitted their documents to the Charity Commission on 27 March 2017, 49 days later than required. The Cheslyn Hay Recreation Ground's financial year ended on 31 March 2016, meaning their documents should have been filed by 31 January 2017. The Authority submitted their documents to the Charity Commission on 27 March 2017, 55 days later than required.

As a result, in our view the correct response to Assertion 9 on Section 1 of the Annual Return is "No". In future, the Authority should ensure that appropriate documentation is submitted to the Charity Commission before the 10 month deadline.
